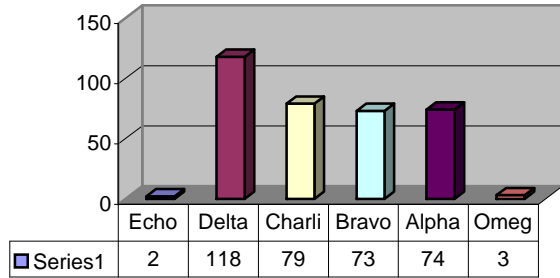

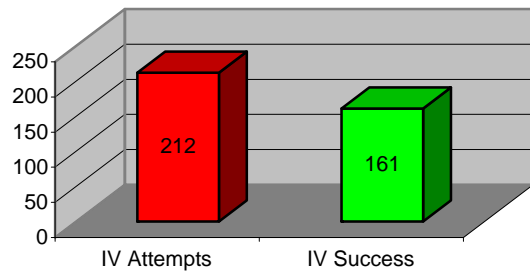

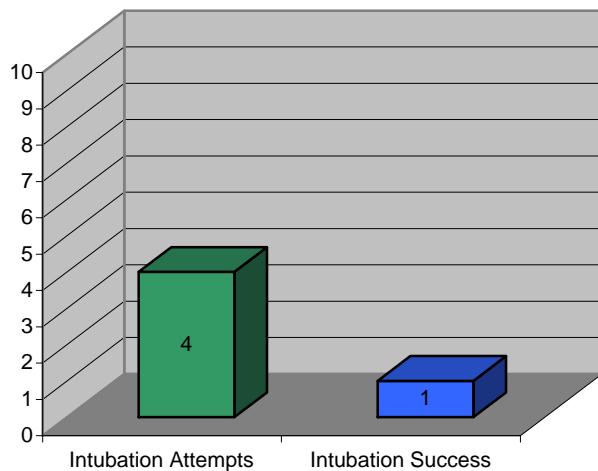
Rogers Fire Department - Emergency Medical Determinants by Classification (May 2011)



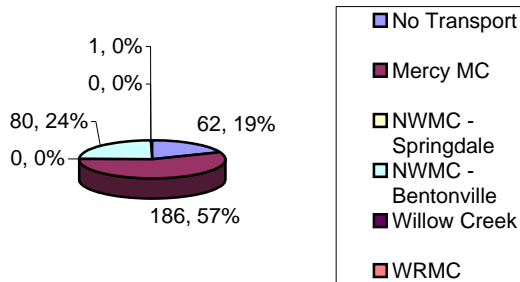
Intervenous Start Performance
